The **Festus/Crystal City Elks Lodge #1721 Scholarship Program** provides financial assistance based on need, leadership experience, community involvement and scholarship achievement, and is open to all high school students graduating by June 1st of the application year. To qualify, the student must be AT LEAST one of the following:

- the child, stepchild, grandchild, or step grandchild of a current Lodge #1721 Elk with at least 12 months' membership in good standing at Lodge #1721 at the time of application.
- be graduating from one of the following schools: Festus High School, Crystal City High School, Herculaneum High School, Jefferson R-VII High School, St. Pius High School, Hillsboro High School or Twin City Christian Academy.

Verification of full-time enrollment in an accredited institution of higher learning will be required EACH semester before any financial awards are distributed. Payments will be paid directly to the institution in two distributions: one-half in the following Fall and one-half in the subsequent Spring. Payments may not be deferred in any way.

Financial payments will be made ONLY AFTER the student provides certified verification from the educational institution (letterhead or email directly from the school) of:

- Fall Semester Enrollment Verification: Due by September 1st
- Spring Semester Enrollment Verification: Due by February 1st

General Instructions:

- Only COMPLETE, legible applications will be accepted for review and consideration.
- Official high school transcripts of student's enrollment and academic performance from the beginning of 9th grade to date of application may be photocopies but must bear an original signature of proper school authority.
- Neatness and overall presentation of the entire submission will be taken into consideration. Copies of exhibits or achievement in scholarship, leadership, athletics, community service, employment or other activities may be attached, but avoid repetition.
- Custodial Parent(s) is defined as the parent or guardian the applicant lived with the most in the last 12 months and who provided the greatest amount of financial support.
- All applications become the property of the Festus/Crystal City Elks Lodge #1721 of the BPOE.
