Dear Friends of St. Pius X,

As we enter a new school year, I want to take a moment to share our gratitude and just a small portion of the goodness within the halls of St. Pius X High School. The support from those listed in The Advancement Review is awe inspiring and humbling.

For over 60 years, St. Pius X High School has been providing an exceptional Catholic secondary education. Such a great accomplishment is a true testament to the value of a vibrant Catholic community. We know first-hand the importance of education and we had a successful year. This is evidenced by the senior class of 2021, who had an average GPA of 3.57 and an average ACT composite score of 22.9, with the top 25% of that class posting an average of 29.7 and the top 50% in the class posting a 27 ACT composite.

Because of the generosity of so many, we have also been able to make many improvements to our campus. We constructed a new Outdoor Classroom behind the school that provides a great place for teachers to instruct students, for students to enjoy during the lunch hour and for many to congregate. The front office got a whole new look. The wall and lockers between the front office and hallway were removed. They were replaced by a glass wall, a built-in seating area and a trophy case. The Barb Charboneau softball field got new infield dirt and a new pavilion was built to provide shade for both softball and tennis spectators. Construction on the Mezzanine level in the Wellness Center got underway August 20. This new upper level will primarily be dedicated to cardiovascular activities. It will also provide a nice, climate controlled viewing area to catch a game on our stadium field. We have added Wrestling to our sports program and are constructing a new upper level to the right of the stage in the gym. This space will also be used for Cheer and the space created under the new level will be used for Band and Choir storage.

We are making progress to obtain the property in front of the school. We received a significant donation and have a few other commitments. In addition, we are working on funding from grants and soliciting donations. If anyone is interested in contributing, please contact Jim Lehn (314) 608-0669.




